ACORD has released a new form: ACORD 130 CA (2019/01); California Workers Compensation Application.

While it remains ACORD's practice to release forms at the beginning of the month, this form is being released "mid-cycle" due to a recent Notice from the State of California, Department of Insurance. This Notice requested the cessation of collection of responses regarding Disability and Age on ACORD Form 130 and therefore, ACORD is releasing this form at this time.

**1. ACORD 130 CA (2019/01)**  
**California Workers Compensation Application**

This new form was developed in response to a Notice of the State of California, Department of Insurance. This Notice requested the cessation of collection of responses regarding Disability and Age on ACORD Form 130. This Workers Compensation Application provides for workers' compensation, employer's liability, and voluntary compensation coverage.

This is a new form and the following are key differences between this form and the ACORD 130:

1. Title reflects "California Workers Compensation Application".
2. This version eliminates questions 10 and 13 from the General Information section (page 3).
3. Page 1 under Individuals Included/Excluded removed references to Missouri and added:
  - a. "OWNERS" and "Exclusions or waivers in California must meet the requirements of Cal. Labor Code §§3351 and 3352."
4. Page 4, removed all out of State Fraud language references.
5. New logo for ACORD (top left corner of page 1) and new edition date and copyright date (bottom of each page of the form.)
