### **ACORD P&C and Life/Annuity/Health Form Changes and Additions**

The following pages include both a list of new and recently revised ACORD forms and an Explanation of the Changes made.

In 2013, we made an enhancement to our filing and forms release processes. Whenever possible, new and revised ACORD forms will be made available one to six months in advance of the form effective date. In these instances, companies will have this additional time to implement the forms into their systems before the current versions are replaced. Both the current versions and the revised future effective date versions will be found on the **Forms Portal** page at [www.acord.org](http://www.acord.org). The effective date included on the footer of all forms will match the date the form must be used in all jurisdictions in order to ensure compliance with our filings.

The Related Forms document lists Parent forms and their children (the forms that may or should be attached to the Parent form). This file will be updated any time new ACORD forms are added to the current library.

**1. ACORD 304 (2018/08)**

**National Flood Insurance Program- Flood Insurance Cancellation/Nullification**

1. Changes were made to the form based on the CANCELLATION/NULLIFICATION April 2018 National Flood Insurance Flood Insurance Manual. Items 14 and 16 were deleted as were considered “deactivated” as per the NFIM.
2. Form Edition and copyright dates were changed.

**Revisions State Specific**

**1. ACORD 61 ID (2019/01)**

**Idaho Auto Supplement - Idaho Uninsured Motorist and Underinsured Motorist Disclosure Statement**

In response to the Idaho Department of Insurance’s adoption of an amendment to IDAPA 18.01.20, ACORD made changes to this Form to be issued by carriers regarding uninsured and underinsured automobile insurance pursuant to Idaho Code § 41-2502(3).

1. While this form replaces a pre-existing 61 ID (2009/01), there are many textual changes. These changes include setting forth a description of the minimum liability requirements in Idaho and signature lines for rejection for Uninsured and Underinsured Motorist Coverages.
2. This form was designed to match IDAPA 18.01.20 and includes a second page that is set forth in Appendix A of the Administrative Code.
3. Further, the Edition Date and Copyright changed.

**2. ACORD 90 ID (2019/01)**

**Idaho Personal Auto Application**

In response to the Idaho Department of Insurance’s adoption of an amendment to IDAPA 18.01.20, ACORD changed this Form to be consistent with Idaho Code § 41-2502(3).The following changes were made:

1. Addition to Page 1 of "EUIM" in the Underinsured Motorists section under Coverages/Premiums with "Ea Person" and "Each Accident" along the row, along with "\$" representing the additional premiums.
2. On Page 4 of the form, "(UM)" following uninsured and "(UIM)" was added following Underinsured and deleting "(BI)".
3. Edition Date and Copyright changed.

**3. ACORD 60 MA (2018/09)**

**Massachusetts Property Insurance Underwriting Association Application for Homeowners Insurance**

At the request of the Mass. Property Insurance Underwriting Association, changes were made to the form as follows:

1. On the first page WIND/HAIL was deleted NAMED STORM replaced. Elabel change for the field made.
2. Change the copyright date and the edition date.

**4. ACORD 65 MA (2018/09)**

**Massachusetts Property Insurance Underwriting Association, Application for Dwelling Fire**

At the request of the Mass. Property Insurance Underwriting Association, changes were made to the form as follows:

1. Changes to the first page deleting WIND/HAIL and putting in NAMED STORM. Elabel change for the field
2. Revised Copyright dates to 2018 and date of Form.

**5. ACORD 90 OR (2018/08)**

**Oregon Personal Auto Application**

ACORD made changes to this form in response to the Oregon Division of Financial Regulation Bulletin DFR 2018-3. This form allows the applicant to select "M, F, or X" for gender.

1. On page 2 of 4, ACORD added language "AND SEX" after name, and before (AS IT APPEARS ON LICENSE).
2. At page 4, ACORD added language to 90 OR (2018/08) with language that states that "if the applicant is requested to complete the sex or gender indication on this application, applicants who have chosen the not-specified election on their driving records, can indicate "X" for gender."
3. Additionally, at page 4, lines were deleted from the Remarks section (top of the page) to accommodate the new language described above.
4. Edition date and Copyright have changed.

**6. ACORD 290 OR (2018/08)**

**Oregon Personal Auto Application Section**

ACORD made changes to this form in response to the Oregon Division of Financial Regulation Bulletin DFR 2018-3. This form allows the applicant to select "M, F, or X" for gender.

1. On page 2, added the language " AND SEX" on page 2 following the NAME and before (AS IT APPEARS ON LICENSE).
2. To page 3, ACORD added language to 290 OR (2018/08) with language that states that "if the applicant is requested to complete the sex or gender indication on this application, applicants who have chosen the not-specified election on their driving records, can indicate "X" for gender.
3. Additionally, space in the Remarks section in page 3 to accommodate the new language described above.
4. Edition date and Copyright have changed.

**Florida Commercial Insurance Application Applicant Information**

No changes were made to the static form. Enlarge the fillable field for Elabel 533 to accept 5 bytes

No changes were made to the static form. Enlarge the fillable field for Elabel 533 to accept 5 bytes.

**3. ACORD 401 (2016/03)**

**Agriculture Application**

No changes were made to the static form. Enlarge the fillable field for Elabel 533 to accept 5 bytes.

**4. ACORD 407 (2016/03)**

**Livestock Mortality Section**

No changes were made to the static form. Changes to the Elabels were made on page 3 of 4, changing the additional interests (name and address fields) and changes to the Elabel for Aircraft on page 3.
