Swiss Re's change in eAccounting & Claims Steering Committee representation

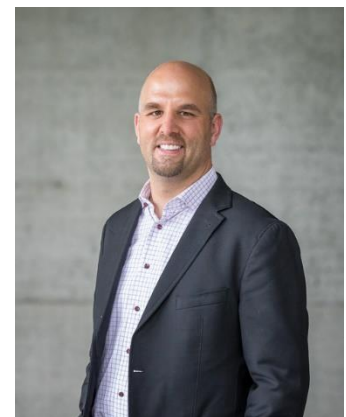
