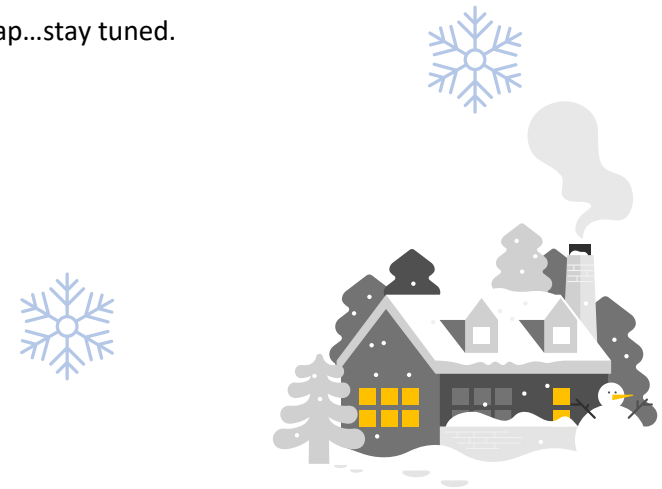
Happy Holidays from the Ruschlikon ePlacing SteerCo Chair

A Very Happy Holidays from the Ruschlikon UK (RUKIG)

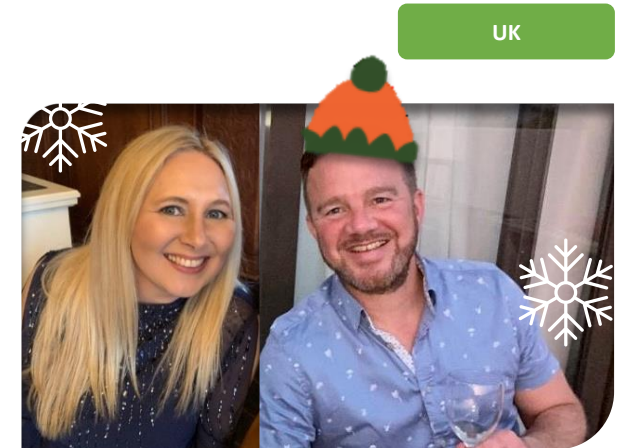

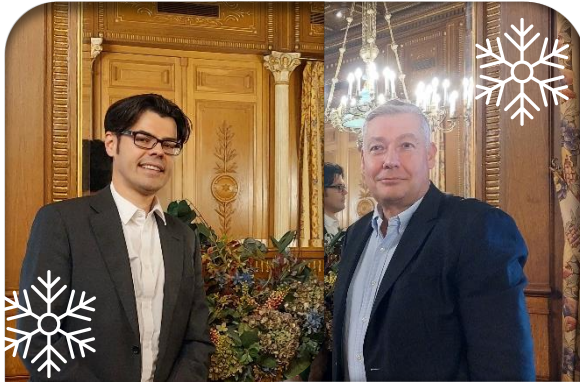
2024 looks to be the most exciting and a little overwhelming for some and we are very much looking forward to supporting and delivering with everyone.

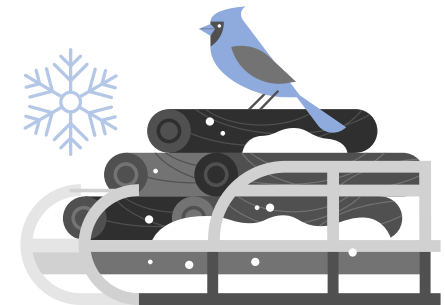

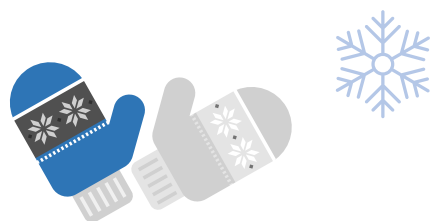

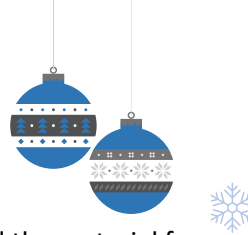
